CIRCULAR

Sub : Examinations and Academic Session 2020-21.

It is very unfortunate that COVID 19 Pandemic is not getting contained. The spread of COVID 19 has thrown the entire academic planning out of gears. This challenge has to be converted as an opportunity by the Academicians and the Academic Leaders.

- In view of the COVID 19 Pandemic, all the examinations scheduled are postponed until further orders.
- However, the Academic Session of 2020-21 should be commenced.
- All the Principals/Directors are requested to commence the Academic Session before 15th July, 2020. The teaching should be done online. A detailed timetable should be provided to all the students. Arrangement should be made to get all students involved in this online teaching and learning process.
- The Academic Council at its 61st meeting held on 30th June, 2020 has resolved the following.
 - (a) All the students shall be promoted to the next semester/year subject to the condition that they will appear and clear the examination of the course in which he or she has failed /not able to attend whenever the examination is held next.
 - (b) The ATKT Rules and the Carry Forward Rules are kept in abeyance. Therefore, irrespective of number of subjects remaining as backlog, the students shall be promoted to the next semester/next year.
 - (c) A committee has been constituted to work out a scheme of assessing the students for the previous semester/previous year. Based on the recommendations of the committee, the result for the previous semester/previous year will be declared in due course.
 - (d) The students are allowed to improve their grades by offering additional opportunity to appear for the current semester course in succeeding semester/year or through supplementary examinations. The students will be informed well in advance about the conduct of examination and other related activities.
- All the students should enroll for the next higher semester/year by applying and paying the necessary fee for their enrolment.

- Further decisions will be taken based on the improvement in the situation. It is once again reiterated that –
 - (i) Pending declaration of the result of the previous semester/year, all the students are promoted to the next higher semester/year.
 - (ii) All the students should be enrolled for their next higher semester/year by applying and paying the necessary fee.
 - (iii) The next Academic Session will be started through online. A detailed timetable alongwith the allotted teacher will be provided by the respective colleges to the students through online.
 - (iv) The results of the previous semester/year will be declared in due course.
 - (v) The students will be given an opportunity to improve their grades in the succeeding semester by appearing for the examination subsequently, whenever it is held.
