The seats will be allotted in the order of merit as per intake capacity of the programme in **Regular Merit Category (Self Financing Section)**. Call for counseling is not guarantee of seat, it is subject to intake capacity in regular merit category and availability of a seat at that point of time.

Kindly attend the counseling with all relevant documents in original and photocopy. You must submit all the original documents in the college at the time of counselling and on the spot admission. If you are given provisional admission then you will be required to pay the tuition fees on the day of counselling itself, failure to remit the full fee will result into loss of your claim for the seat.
