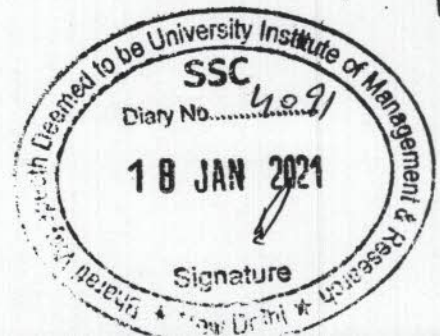

Respected sir,


The Summer 2020 examinations were not held due to Covid-19 pandemic. Based on the directives of the University authorities, the result of the students of Intermediate Semester (Summer 2020) were prepared by using the recommended formula. The marks for the Project Practical / Departmental marks were also awarded based on the formula.

However, it is observed that some institutions had conducted the Project / Practical / Departmental marks for the Intermediate Semester students through online mode during the pandemic situation. It is also to be noted that, many students had secured higher marks in the Project / Practical / Departmental examinations conducted by the Institutes in comparison to what has been awarded based on the formula.

Considering the above situation, we recommend that the comparison should be made with respect to the marks awarded to the students based on the formula and the marks secured by the students in the Project / Practical / Departmental examinations conducted by the Institutes and whichever is higher, be awarded to the students.

However Institutes who conducted practical, viva, project examinations etc be asked to submit all the documentary proofs of it. This decision will not be used as precedence and all the examination rules and regulations must be followed in letter and spirit by all.
