CIRCULAR

Due to the Covid-19 Pandemic and consequent Lockdown from March 2020, many universities could not conduct the Final Year Examinations in time. Similarly, many Higher Secondary Boards have also not conducted the examinations in time. Wherever the examinations were conducted the Mark-sheets were not released in time.

However, in order to save the precious one academic year, the admissions were carried out based on the information provided by the candidate such as Mark-sheet of the previous examination, xerox copy of the final examination Mark-sheet and certified copy of the mark-sheets given by the institution last studied. Efforts are being made to verify the Original Certificates for eligibility clearance. However, most of the students are not in a position to submit the Original Certificates.

Pending submission of the Original Certificates and consequent clearance of the eligibility, the students were allowed to appear for the 1st year examinations.

Now, it has been decided to release the result of all the candidates including those who have not yet fulfilled the requirement of submission of the Original Marksheets for verification.

All the students may kindly note that in the event of not fulfilling the requirement of eligibility for admission to the concerned programme, at any point of time, the admission given will be automatically cancelled without any liability to the university.

All the students are hereby requested to get their eligibility cleared from the University through their concerned college at the earliest.
