Subject: Preparation and submission of time table for backlog examinations (Summer 2020) and regular Winter 2020 examinations.

Sir/Madam.

Based on the examinations and other modes of evaluation, the university declared the results for all programmes of the Summer 2020 examination season. The authorities of the university have decided to conduct backlog examinations of the students of intermediate semester / year which will be held from 21st December 2020 through remote proctored online MCQ mode. You are required to communicate to the concerned students about the commencement and schedule of examinations immediately. This examination will be termed as "Backlog examinations - Summer 2020" and shall be exclusively for only those students who had backlogs and filled their examinations forms in Summer 2020 season. There is no need of any examination form filling as these students have already paid the examination fees. The examination section has the record of such students and a report of the same will be provided to the concerned institute. Please note that the final year students as of Summer 2020 will not be allowed to appear for this examination as the they were provided the opportunity to appear for the regular and backlog examinations.

You are also requested to enter the mobile and emails of the above-mentioned students who will be appearing for backlog examinations through the online examination software. The timetable has to be prepared for the all the semesters / years except the final semester / year by 8th December 2020. Please enter the timetable in the online examination software under Summer 2020 season, however please do not make any change in the dates of the final semester / year in the timetable.

You are also required to prepare the examination timetable through the online examination software for Winter 2020 commencing from 1st February 2021. The examination will be held through online MCQ mode. Once the timetable is prepared you are required to fill the examination forms for all the students who will be appearing for Winter 2020 examinations except the backlog students whose examination will be conducted from 21st December 2020. The results of the backlog students will be prepared immediately and thereafter these students can fill their examination forms for Winter 2020 examinations.
